- (1) When the District (i) receives a request for sewer service from an owner or resident of an existing unserviced subdivision or (ii) learns that there is one or more failed septic system in an existing subdivision, the District Manager will direct that a study be conducted as to the need for sewer service for
- (2)Upon completion of the study the District Manager and staff will report to the Board the results of the study. The study may include, but not be limited to such areas as:

- Location of affected area relative to WCCD service area
- b) Severity of problem and interest shown by affected parties
- c) Recommendation(s) by County Board of Health authorities based upon knowledge of existing problems and complaints from affected parties and authorities
- d) Number of prior inquiries for servicing the affected area and number of homes
