RESOLUTION OF THE BOARD OF DIRECTORS OF WEST CENTRAL CONSERVANCY DISTRICT REGARDING DECLARATION OF OFFICIAL INTENT TO REIMBURSE EXPENDITURES

WHEREAS, the Board of Directors (the "Board") of the West Central Conservancy District (the "District"), a special taxing district and political subdivision of the State of Indiana, has heretofore established, acquired and financed its sewage works, and now owns and operates said sewage works pursuant to IC 14-33, as supplemented and amended; and

WHEREAS, the Board of the District, intends to make certain improvements and extensions to its sewage works and in connection therewith will make certain expenditures for the costs thereof, all as more specifically set forth on Exhibit A hereto (the "Project"); and

WHEREAS, the District reasonably expects to reimburse the costs of the Project with proceeds of debt to be incurred by the District; and

WHEREAS, for purposes of this Resolution, the term "debt" is intended to include tax-exempt bonds; and

WHEREAS, the District expects to issue, or have issued on its behalf, debt not exceeding Twenty-Four Million Nine Hundred Ten Thousand Dollars (\$24,910,000) in aggregate principal amount for purposes of paying or reimbursing the payment of costs of the Project; and

WHEREAS, the District intends that this Declaration of Official Intent to Reimburse expenditures constitutes a declaration of official intent pursuant to Treas. Reg. §1.150-2; and

WHEREAS, this Resolution shall be in full force and effect from and after its passage.

NOW, THEREFORE, BE IT RESOLVED that the District declares its official intent pursuant to Treas. Reg. § 1.150-2 to acquire, construct, install and equip the Project and to pay or to reimburse the payment of certain costs of the Project with proceeds of debt to be incurred by the District; and to issue, or have issued on its behalf, debt not exceeding Twenty-Four Million Nine Hundred Ten Thousand Dollars (\$24,910,000) in aggregate principal amount for purposes of reimbursing costs of the Project.
