

PUBLIC NOTICE

INVITATION FOR NOMINATION TO FILL VACANCY  
ON THE BOARD OF DIRECTORS

The Board of Directors of the West Central Conservancy District hereby invites nominations to fill the vacancy on the Board of Directors created by the expiring term of Director William E. Holland, Director of Area 5.

Area 5 is described as follows:

Beginning at the Northeast corner of Section 15, T15N, R1E; thence South along the East line of said Section 15 and Section 22 to the Southeast corner of Section 22, T15N, R1E; thence West along the South line of Section 22 to the Southwest corner of the West half of the Southeast quarter of Section 22, Township 15N, Range 1E, thence West 305 feet to a point thence North 36 degrees 46 minutes 13 seconds East 352.58 feet to a 5/8" rebar with plastic cap, thence North 00 degrees 13 minutes 52 seconds east 350.00 feet to a 5/8" rebar with plastic cap; thence South 83 degrees 13 minutes 53 seconds West 585.16 feet to a 5/8" rebar with plastic cap; thence North parallel to the West line of the West half of the Southeast Quarter 958.34 feet to a point 861 feet South of the north line of the Southeast Quarter thence West parallel to the North line of said Southeast Quarter to the West line of the Southeast Quarter, (being also the East line of the Southwest Quarter of Section 22) thence North on the East line to the center of the road at a point which is 34.75 rods South of the Northeast corner of the Southwest Quarter of Section 22, thence run South 81 1/2 degrees West on and along the center line of said road to a point which is the Southeast corner of a tract of land conveyed by quitclaim deed recorded as instrument number 200000003113 recorded in Book 162, page 913, thence continue South 81 degrees 00 minutes 49 second West 377.84 feet, also being at the centerline of White Lick Creek, thence West parallel to the South line of Section 22 to the West line of Section 22; thence North on the West line of Section 22, to the Southeast corner of the Northeast Quarter of Section 21, T15N, R1 East thence to a point in the center line of White Lick Creek, which point is North 0 degrees 06 minutes 13 seconds West 95.00 feet, measured along said east line, from the southeast corner of said half-quarter section; thence North 26 degrees 25 minutes 00 seconds West along said center line 100.00 feet; thence North 49 degrees 00 minutes 00 seconds West along said center line 303.00 feet; thence North 71 degrees 00 minutes 00 seconds West along said center line 225.00 feet; thence South 86 degrees 00 minutes 00 seconds West along said center line 188.00 feet; thence South 60 degrees 30 minutes 00 seconds West along said center line 248.00 feet; thence South 73 degrees 25 minutes 00 seconds West along said center line 250.00 feet; thence North 78 degrees 00 minutes 00 seconds West along said center line 90.00 feet; thence North 68 degrees 20 minutes 00 seconds West along said center line 140.46 feet to a point on the west line of said half-quarter section; thence North on the West line to the Northeast corner of the West half of the Northeast Quarter of Section 21; thence West along the North line of Section 21, T15N, R1E to the Northeast Corner of Section 20, T15N, R1E (being the Northwest corner of Section 21, T15N, R1E); thence continue West on the North line of Section 20, T15N, R1E to the Northeast corner of Section 19,

T15N, R1E (the Northwest corner of Section 20, T15N, R1E); thence West along North line of Section 19, T15N, R1E to the Northeast corner of Section 24, T15N, R1W (being the Northwest corner of Section 19, T15N, R1E); thence West along North line of Section 24, T15N, R1W to the Southeast corner of the Southwest Quarter of the Southwest Quarter of Section 13, T15N, R1W (being the Northeast corner of the Northeast Quarter of the Northwest Quarter of Section 24, T15N, R1W); being also the intersection of County Road 200 S and County Road 225 E; thence North on the East line of the West Half of Southwest Quarter of Section 13, T15N, R1W (also being the center line of County Road 225E) to the Northeast corner of said West Half; thence continue North on the East line of the West Half of the Northwest Quarter of said Section 13 to the North line of said Section 13; thence East on said North line of Section 13 to the Northeast corner of Section 13, T15N, R1W; thence to the Northwest corner of Section 18, T15N, R1E; thence East on the North line of Sections 18, 17, 16 and 15, T15N, R1E, to the Northeast corner of Section 15, the point of beginning.

The street address or other common designations, if any, of the real property described above as Area 5 is purported to be all that land located within an area bounded by:

State Road 267 on the East, also the Timber Bend, Auburn Meadows and Jessup Meadows subdivisions; the North line of Sections 20, 19, T15N, R1E and Section 24, T15N, R1W, on the South; County Road 225E on the West and the North lines of Sections 13 and 18 and County Road 100S on the North.

A nominee for director to be qualified to fill the vacancy must be a freeholder of Area 5 or an officer or nominee of a corporate freeholder of Area 5 and must be qualified by knowledge and experience in matters pertaining to the development of the West Central Conservancy District.

Nominations for director must be submitted (delivered or postmarked) to the West Central Conservancy District, 243 South County Road 625 East, Avon, IN 46123, before December 1, 2013 and in accordance with Indiana statute.
