Plant Operation Report as presented by Manager. Manager reported Class A sludge currently being tested by a farmer, Manager will report results as tests continue.

W. Holland expressed concerns of manhole rehabilitation project. Manager explained WCCD process on repair of manholes in the District.

J. Crowe again thanked WCCD staff for their hard work during the building expansion project.
