Manhole covers require free and clear access

Manhole covers provide access for inspection, repair and maintenance of sewer lines. As the District's operators are out doing this work, they sometimes find that manholes have been buried, either intentionally or accidentally, by landscaping, earthen fill, paved driveways or similar activity. This makes it very difficult to provide the required level of service expected by our customers and by regulatory agencies.

More importantly, buried manholes can create a serious problem for you, your neighbors and the District if there is a blockage in the sewer line and access is not immediately available. This can lead to a sewage backup into a basement or spillage of sewage onto the ground.

"Many people don't realize the trouble that a covered manhole can cause in this situation," explained Gary Padgett, the District's supervisor of system operations. "Please be sure that you don't cover a manhole in your yard in any way, for any reason. Or if you notice that a manhole has become buried, be sure to call the District so we can send out our crew to raise it before it becomes an emergency."

Padgett said customers will be notified in advance if their manhole is

going to be raised. A crew will then come out to raise the buried manhole to ground level by digging it up, usually manually, to expose the manhole, then setting it up using riser rings. Care is taken to finish the job by replacing the existing sod whenever possible.

Remember, open manholes can be dangerous and can cause significant amounts of rainwater to go into the sewer system, negatively affecting plant efficiency and operation costs, so please leave covers on the manholes.

District earns safety award from IWEA

Clay Tile Project set to move into Phase II

Phase I of the Old White Lick clay tile repair project is complete and the District's Board of Directors has approved moving into Phase II. This will involve rehabbing 3 to 4 miles of sewer collection lines in the area east of County Road 525 E.

The lines in this area are among the District's oldest and some cracking and misalignment that has occurred over the years has caused inflow and infiltration (I & I) of rain water into the wastewater system.

"When we get I & I, rain water can overload the plant's capacity to purify the wastewater, especially when there are heavy rains," explained Debbie Sillery, District Manager. "The repairs are necessary to prevent that from happening and maintain the plant's efficiency."

Residents in the affected area can expect to see field investigation crews starting in the Spring. Using the District's camera truck, employees send a camera into the lines to identify the location of cracks, misalignments and roots in the pipes.

Pictures from this assessment will be reviewed and the

District's consultant, VS Engineering, will provide the Board with a work plan based on the findings. The project should be ready to send to bid in late Summer, with work projected to begin in the Fall and proceed through the Winter.

"The District will keep residents in the area informed about the progress of the project," Sillery said. "Many repairs can be made without digging, but when that's necessary, we want homeowners to know that repairs will be done with concern for their property." She said a community informational meeting will be planned and information will also be posted on the District website as the project proceeds.
